

Corrections noted in **red**.

Dominant Species: Marine (2nd printing)

Developer's Note: Resilience was initially supposed to be a lesser version of the Regression ability. It would still be the same 99% of the time as it is rare for a player to have to worry about more than one element in Regression anyway. A Regression cube saves all elements, but Resilience was supposed to automatically save one element at all times.

The text in the rulebook for Resilience should be:

"Your animal is safe from one element of your choice being lost to Regression during a Reseed event. You may still place real cubes in Regression to either protect against multiple element losses or to possibly deny a rival animal an opportunity to save their own elements."

The card remains as it is. (*This correction also applies to first printing.*)

Dominant Species: Marine (1st printing)

The markers for tracking the elements' domination values are misprinted (each marker has two different elements on its two sides). **These should be identical front and back.**

The components list in the rulebook claims the element draw bag is black, but it's actually white. (White bags had been accidentally purchased the first time.) **The bags should be black and red. This has no effect on game play.**

Tectonic Shift card: Change last sentence to read "**Take another turn after this one.**"

Phenotypic Plasticity card: **Make element spaces match graphic from the player board.**

Box back, 3rd paragraph: "dinosaur" should be replaced with "**reptile**".

Page 4, item B: "Place five Land tiles, five Ocean tiles, and one each of the other five large tile types into their assigned positions in the center of the hex grid. (Note the **one** Land and **one** Ocean tiles that are shown underneath smaller Hydrothermal Vent tiles.)"

Page 6, Bonus VPs: "The top row of this table lists the count that the action or card effect is checking – for example, how many Vent tiles are occupied by an animal during the Survival **event** [back cover] –

Page 6, Event, second sentence: "Extinction and Survival are triggered by the appearance of fish icons on new evolution cards **as they first enter play.**"

Page 7, Endangered & Thriving, last paragraph: "Endangered species are vulnerable to elimination during an Extinction event [back cover] and can't claim an evolution card during **Evolution** actions."

Page 10, Under the Retrieve example: "She must choose the Retrieve action, collect **her** all of her pawns (basic and special) and place them in front of herself..."

Page 15, the example of Competition shows a previously-placed pawn on a space that has no terrain marker. **Please add a Seagrass Meadow tile to the empty starfish space below the pawn in space 2.**

Page 19, Monotypic Habitat: Remove this sentence: "The food chain is reversed for tie-breaking purposes (not for turn order!) as long as this card remains face-up in a card slot." In its place, please enter: **"Count the number of tiles where your species is alone. The number of species on each of those tiles does not matter."**

Page 21, Pack Hunters - Change to read "The special pawn you choose will have its target marker begin on **space 2 instead of 1.**"

Page 24, first and second bullets of left column, underline "new" for "...new evolution card."
